

Based on Article 22 of the Law on Public-Private Partnership and Concessions (Official Gazette of the Republic of Serbia no. 88/2011, 15/2016 and 104/2016) and Articles 31, 57 and 60 of the Law on Public Procurement ("Official Gazette of the Republic of Serbia" no. 124/2012, 14/2015, 68/2015), hereinafter: "the Law", Republic of Serbia, Municipality of Leskovac, announces the following:

PUBLIC PROCUREMENT IN OPEN PROCEDURE FOR THE SELECTION OF THE PRIVATE PARTNER IN THE IMPLEMENTATION OF THE "PUBLIC-PRIVATE PARTNERSHIP - MODERNIZATION, RATIONALIZATION AND MAINTENANCE OF THE REMAINING PART PUBLIC LIGHTING WITH ENERGY SAVING APPLICATION IN THE CITY OF LESKOVAC".

Type of the contracting authority: Local Self-Government

Type of public procurement procedure: The respective public procurement is conducted in an Open procedure.

The subject of public procurement in the open procedure No. 025-2/19

The selection of the private partner of the Project "Public-private partnership - modernization, rationalization and maintenance public lighting with energy saving application in the city of Leskovac".

Object type: Services.

The subject of a public-private partnership without the elements of concession is the implementation of measures aimed at efficient use of energy (hereinafter: MUE), a corresponding reduction in CO2 emissions and reduction of operational costs of part of public lighting in the city of Leskovac

Number of parties: Public procurement is not formed by parties.

The criterion - the elements of the award criteria:

In accordance with Article 85 of the Law, the selection of the most favorable bid will be based on the criterion of „Lowest bid price” which is determined as the highest offered net present value of the total cost of the contract.

Tender guarantee:

Tenderers must provide a bank tender guarantee of min. 10.000.000,00 RSD when submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender

procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties.

Method of downloading tender documentation:

Tender documentation can be downloaded from the Public Procurement Portal (<http://portal.ujn.gov.rs/>) and the web site of the Contracting authority (www.gradleskovac.org.rs) without any charging.

The bids should be prepared in accordance with the Law. Contracting authority instructions are submitted to the address: **Republika Srbija, Gradska Uprava grada Leskovca odeljenje za javne nabavke , Trg revolucije 16000 Leskovac**

The bids must be delivered in a closed envelope, with a note: „Понуда у отвореном поступку јавне набавке за доделу уговора о јавно-приватном партнерству за вршење услуга реконструкције, рационализације система јавног осветљења на територији града Лесковца ЈН 025-2/19 – НЕ ОТВАРАТИ”.

On the back of the envelope, name and address, phone number and contact person of the bidder should be specified. Bidders submits the bids directly to the administrative office or by mail, to the address of the Contracting authority.

All tenders must be received by the Contracting Authority before the deadline 21.11.2019. , 10.30 clock, by registered letter with acknowledgement of receipt or hand delivered against receipt signed by representative of city of Leskovac

Any tender received after this deadline will not be considered.

* All times are in the time zone of the country of the Contracting Authority.

If the last day for submission of bids is a non- working day, the deadline shall expire on the following working day, at 10.0 clock. Offer received after the deadline for submission of bids will be considered as untimely and will be returned by the Commission for Public Procurement to the bidder, closed, with the note that the bids were submitted untimely.

In case if the bid is submitted by a group of bidders, on the envelope, it must be indicated that it is submitted by a group of bidders with a list of the names and addresses of all participants in the joint bid.

Public opening of bids:

Tenders will be opened in public session on date and venue 21.11.2019. 11.00 clock by the committee appointed for the purpose at the offices of the Contracting authority.

The committee will draw up minutes of the meeting, which shall be available to tenderers on request.

The opening and the examination of the tenders, is for the purpose of checking whether the tenders are complete, whether the requisite tender guarantees have been furnished, whether the required documents have been properly included and whether the tenders are generally in order.

Conditions for participation in the session of opening the bids:

Only authorized representatives of the bidders can participate in the session of opening the bids
- representatives must have proper power of attorney for participating in the bid opening procedure, issued on the memorandum of the bidder, signed and stamped.

Deadline for publishing the Decision on awarding contract:

Deadline for decision on award of contract or suspension of procedure: up to 40 days from the date of opening of tenders.

The deadline for signing the contract is 10 days from the expiry of the deadline for submitting the request for protection of rights.
